Membership Categories

TCS strives to provide useful benefits for every category of membership.

Regular

Receive all member benefits. Dues are \$100 for the calendar year.

New Professional

Professionals who have been out of school for more than two years receive a rate of \$60 for the calendar year. This level includes all benefits except the *Coastal Management* subscription.

Retired

Former professionals over the age of 65 and no longer in full-time employment receive a reduced rate of \$50. This level includes all benefits except the *Coastal Management* subscription.

Student

Currently enrolled graduate, undergraduate or secondary school students qualify for an extremely reduced rate of \$30. This level includes all benefits except the *Coastal Management* subscription.

Library

Any library may become a library member. The cost is \$50 for the calendar year and subscriptions to *Coastal Management* must be made directly with the publisher.

Institutional

Any institution or organization interested in supporting the mission of TCS is welcome to join at the support level of \$250. This includes providing the name of three individuals who will receive all the benefits of a Regular Membership.

Corporate

Any company, business, or organization interested in supporting the mission of TCS at the \$500 level will be given the option to provide six individuals who will receive all the benefits of a Regular member.
