







This summary is not intended to be a meeting transcript. Rather, it focuses on the main points covered during the meeting.

#### MEETING IN BRIEF

During the November 28, 2018 meeting, members of the New York Bight Task Force, other regional representatives, and the public heard updates on the Bureau of Ocean Energy Management (BOEM)'s leasing effort in the New York Bight (NY Bight). BOEM staff reviewed the Call for Information and Nominations (Call), which identifies four potential areas for offshore wind leasing, and the development process for the Draft Wind Energy Areas (Draft WEAs). The Task Force heard updates and reactions to the Draft WEAs from the Department of Defense, the U.S. Coast Guard, the National Marine Fisheries Service, and the Responsible Offshore Development Alliance (a new organization representing a broad range of fisheries interests).

Representatives from the states of New York and New Jersey presented updates on their procurement plans and


The Certification Review Process For Major Electric and Fuel Gas Transmission Facilities










- Define strategies that could help members engage effectively with OSW development.


#### Jobs and Supply Chain
