- Producing sustainability disclosures and other communications aligned with leading frameworks (e.g., CDP, GRI, SASB)
- Researching leading sustainability programs and initiatives
- Managing multiple projects and project teams concurrently
- Supporting business development activities with existing and prospective clients across sectors
