VII. Programmatic Accomplishments

1. TCS Strategic Plan and Committee Workplans

In late 2023 and into 2024, TCS developed a comprehensive, organizational-focused Strategic Plan that describes the vision and goals for TCS over the next two years. Each goal is divided into several detailed Objectives and Action Items, each designed to meet and exceed the mandates of TCS, and to facilitate both current function and growth.

Further, each TCS Committee (with guidance from the Executive Committee) was charged with developing a workplan that integrates its efforts into the overall Strategic Plan, and lists distinct activities that correspond to each Committee's directives.

The four primary TCS goals are:

GOAL ONE: Foster Dialogue

GOAL TWO: Forge and Maintain Partnerships

GOAL THREE: Promote Communication and Education

GOAL FOUR: Maintain a Robust and Sustainable Organization

2. TCS Coastal Forum: November 6, 2023, Wilmington, NC

The Coastal Society, in partnership with the North Carolina Sea Grant (NCSG) and the University of North Carolina-Wilmington (UNCW), held an in-person event *Priority Issues in Coastal North Carolina: A Forum by The Coastal Society* at UNCW's Center for Marine Science. There were 78 attendees.

Panelists representing universities, government agencies, and non-governmental organizations shared insights into their roles in addressing critical topics shaping the future of North Carolina's coastal region, such as:

- Planning and Implementing Coastal Resilience Strategies
- Research and Control of Toxins/PFAS
- Marine Spatial Planning: Offshore Wind Planning and Permitting, Sand Mining

During breakout sessions, coastal experts, managers, advocates, and students introduced themselves, and dove into the challenges of understanding and addressing these issues. Participants had the opportunity to learn more by interacting with student poster presenters. The networking continued afterwards at a local brewery. TCS is deeply grateful to its partners, UNCW and NCSG, and our sponsors, Lynker, Inc., North Carolina Division of Coastal Management, North Carolina Coastal Federation, Duke University Marine Laboratory, and East Carolina University's Coastal Studies Institute, for their invaluable support in making this event possible.

3. Margaret A. Davidson Coastal Career Development Program

In 2023, TCS continued to honor former TCS President Margaret A. Davidson (M.A.D.), a luminary, mentor, and friend, by hosting another 2 career workshops in her name:

- Duke University Student Chapter, January 26, 2023: This workshop was held virtually because the Duke University is a split campus allowing students at the main campus and those at the marine lab to participate, as well as professionals from their offices in several states. A total of 29 people participated.
- NOAA Sea Grant Knauss Fellows Program, August 4, 2023: Held in the NOAA offices in Silver Spring, MD, 40 people participated including the Knauss Fellows, speakers from diverse fields and perspectives, and the workshop team.

These workshops are designed to foster the next generation of coastal practitioners and stewards by helping students and early career professionals learn which skills, tools, and industry knowledge are in demand, and how to apply this knowledge in their career or job search. Each event is designed to meet the needs of expected participants and reflects the creative thinking of the M.A.D. Coastal Career Development Committee and valued partners. TCS continued to refine its processes for planning and conducting virtual sessions, and in 2023 experimented with "hybrid" events that allowed for both inperson and online participation. TCS also broadened its approach to include more speakers from varied backgrounds, and tailored workshop topics to the interests and regional characteristics of the partnering institutions. A hearty thank you to the generous 2023 workshop sponsors and partners, including: ERT Corp., Chesapeake Bay National Estuarine Research Reserve-Virginia, Lynker, Inc., Duke University, and NOAA Sea Grant.

In 2024, TCS plans to host several more virtual and in person career workshops. TCS members are eligible for free or discounted registration rates. For more information on the M.A.D. 4. Diversity, Equity, and Inclusion Initiatives

The Coastal Society advanced our commitment to fostering a culture of advancing diversity, equity, and inclusion by implementing a 2022-2027 Diversity Equity, and Inclusion (DEI) Strategic Plan. The DEI workgroup, which grew by another four members in 2022, led the charge, and is continually working towards complete integration of these initiatives throughout TCS as an organization and all of its efforts. 5. The Coastal Society Coastal Connections Web Conferencing Series

Coastal Connections is a web conferencing series launched in 2020 to engage TCS members and the broader coastal community through virtual web presentations and discussions. The series consists of two session types: <u>Trending Topics</u> and <u>Professional Spotlight</u>. Trending Topics sessions feature expert panelists who present on new or pressing coastal issues, followed by an opportunity for members and guests to ask questions of the panelists and offer their own insights on the topic. Professional Spotlight sessions are designed as a members-only opportunity to learn about the career paths of seasoned TCS coastal professionals, with a short presentation followed by open dialogue between the guest speaker and all participants. On February 23, 2023, this session focused on NOAA's National Marine Sanctuaries program, which celebrated its 50th anniversary in 2022. Topics covered included the history of the program, the value of the program in achieving its conservation goals, the challenges and rewards of working with local and regional stakeholders, and the diversity of sanctuaries as reflected in a few of the currently proposed sanctuary sites.

Blue Carbon Planning

On October 11, 2023, this session focused on how states can address the climate crisis by setting greenhouse gas reduction targets and developing related policies, including strategies to reduce emissions and enhance carbon storage in their natural and working lands. Due to their ability to sequester and store carbon, coastal blue carbon ecosystems such as tidal marshes, seagrasses, and mangroves are increasingly being incorporated into policy discussions around climate mitigation. However, the inclusion of blue carbon into state climate strategies can be challenging, and progress is dependent on a variety of factors, including data availability, funding resources, and effective governance arrangements. In this Coastal Connections session, The Pew Charitable Trusts and the Maryland Department of Natural Resources shared existing strategies and resources that states have utilized to overcome some of these challenges and incorporate blue carbon into state climate planning.

Each chapter is empowered to design and host local activities focused on coastal issues, such as organized beach clean-ups. TCS recognizes the continued leadership of members of Duke University and East Carolina University to continue production of the *All Swell?* Podcast, in coordination with the American Shoreline Podcast Network. 9. Annual Giving Campaign




